Welcome!

Welcome to the first edition of the CALORIES newsletter!

We are currently working towards opening the trial to patient recruitment and encourage Sites to push through with local approval paperwork (Trust R&D approval letter and completion of the Clinical Trial Site Agreement (CTSA)). Please ask the CALORIES team if you have any questions or require any help with these documents.

Sites in set-up

We have 22 Sites competing to take part in CALORIES. Sites will need to have local approval paperwork in place and meet the inclusion criteria (described opposite).

Site inclusion criteria

20 Sites are required for CALORIES, and are being recruited following completion of the Clinical Trial Site Agreement (CTSA) (signed and returned to ICNARC), receipt of the Trust R&D approval letter at ICNARC and through meeting the criteria below. This will be done on a first-come first-served basis.

- Participation is dependent on timely submission of CMP data:
- Pre-existing, established protocols for EN and PN reflecting mainstream practice and completion of CALORIES trial paperwork;
- Pre-existing implementation of bundles as promoted by the NHS (NHS Saving Lives: reducing infection, delivering clean and safe care - High Impact Intervention Number 1: Central venous catheter and Number 5: Ventilator) promoted to prevent the development of bloodstream infection and ventilatorassociated pneumonia (VAP);
- Agreement to incorporate CALORIES into routine unit practice, including prior agreement from all consultants in the unit to adhere to the patient's random allocation for nutritional support (PN or EN);
- Agreement to recruit all eligible patients to CALORIES and to maintain a Screening Log of eligible patients screened but not recruited;
- Sign up from the unit Clinical Director, Senior Nurse Manager, Dietician/Clinical nutritionist and Pharmacist:
